

# BOND AGENT PARTNER GTE/GS CHECKLIST

Applicants for Student and Student Guardian visas must show they are coming to Australia temporarily for study as a Genuine Student (GS) and are assessed against the Australian immigration authority's Genuine Temporary Entrant (GTE) criteria.

Bond University reserves the right to refuse admission if the University is not satisfied that the applicant meets the GTE/GS criteria and/or does not have the capacity to study and live in Australia for the duration of the program even if the offer has been accepted by the applicant. The University may also impose additional requirements on applicants who will require Australian student visas to commence study. Applicants who do not meet these requirements at the time of application or acceptance will be refused admission.
