BEST SEMESTERS TO GO ABROAD

- UG Students may undertake a semester abroad through the Bond Exchange Program from their fourth semester onwards. PG students may go on Exchange in their third or fourth semester (note: applications must be submitted two semesters in advance).
- The Bond September semester often lines up very well with the 'Fall' semester at our partner institutions.
- Students hoping to go abroad during the January (Spring) semester should be careful to check the semester dates at the host institution to ensure there is minimal overlap.
- Options for the May semester are limited to select partners in Thailand, Germany, Japan and Canada only. This is because it is the summer holiday break in the Northern Hemisphere at this time. See the Exchange [website](#) for the full list.
- Students may go on exchange in their final semester, though it could delay graduation.

ACCREDITATION REQUIREMENTS

Students studying Actuarial Science or an Accounting major need to be aware of the accreditation requirements associated with their degree.

The following subjects must be taken at Bond and are not able to be taken on Exchange (even if a matching subject is found) in order to receive industry accreditation upon graduation:

Auditing & Tax Practice can be studied at an approved institution or undertaken with CPA, refer to CPA website. Otherwise all subjects noted above are required to be completed for CA accreditation. Unless approval for subjects taken on exchange are endorsed by CPA or CA directly. Bond University can only offer confirmation of knowledge met if students complete the above subjects on campus.

FULFIL BUSINESS DEGREE REQUIREMENTS

MGMT11-103 and ENFB11-100 (if a requirement of your degree) must be taken at Bond and cannot be taken on Exchange.

ACADEMIC PLANNING

Most students will need to deviate from the recommended sequence of study in order to fit an exchange semester into their degree program, so it is important to plan ahead to make sure you stay on track for graduation.

We recommend saving any electives and major elective options for Exchange to give you flexibility when enrolling at the host university, as core and mandatory major subjects can be hard to match and subject availability at the host university is not guaranteed.

UG students may need to choose between taking a second major/ minor and undertaking an Exchange semester.

PG programs that support an exchange are Master of Business (without a specialisation), Master of Business Administration and Master of Financial Management.

INTERNATIONAL STUDENTS

International students planning to apply for a Temporary Graduate visa (subclass 485) at the completion of their Bond degree should check the visa eligibility requirements before applying for Exchange.

PARTNER UNIVERSITIES

There are many excellent partner institutions where Business students may go on Exchange. Students should consider their long-term academic and professional goals, as well as on-campus degree requirements when selecting an Exchange destination. Students are responsible for investigating the semester start and end dates at the host institution.


