### 1. PURPOSE AND OBJECTIVES

Bond University aims to provide a high-quality experience to prospective and continuing [Students](#) through an admission process that is:

- student-centred;
- equitable and transparent;
- efficient and effective; and
- quality assured.

Bond University is committed to the creation of an environment where everyone is treated fairly and with respect, and free from racism and unlawful discrimination.

The University is committed to providing detailed information on the entry requirements for its programs and to complying with all relevant national regulatory requirements and standards, in particular the *Higher Education Support Act 2003* and the *Education Services for Overseas Students Act 2000*.

This Policy outlines Bond University's admission standards in support of these aims.

### 2. AUDIENCE AND APPLICATION

This Policy applies to [Applicants](#) for [Enrolment](#), and students enrolled, in a coursework [Subject](#) or program at Bond University.

The prescribed qualifications for admission to a [HDR](#) program are outlined in the Higher Degree by Research Programs Policy.

### 4. POLICY STATEMENT

#### 4.1. Minimum Entry Requirements

Bond University sets minimum entry requirements for admission to ensure that students can undertake its programs with a reasonable prospect of success.

Minimum entry requirements are specified within program approval documents, approved by Academic Senate, and published on the Bond University website. Changes to minimum entry requirements must not disadvantage any students who have already accepted offers into Bond University programs.

Minimum entry requirements may include one or more of the following criteria:

- Academic merit;
- English language proficiency;
- Formal and informal prior learning; and
- Relevant measures of success such as special tests or folios.

For further details relating to [Undergraduate](#) or [Postgraduate](#) admission, refer to [Schedule A](#) (Undergraduate Admission Requirements) or [Schedule B](#) (Postgraduate Admission Requirements).

#### **4.2. Minimum Age for Admission**

Bond University requires the student to be 17 years of age by the program commencement date unless specific criteria are met. Refer to [Schedule C](#) (Minimum Age Requirements).

An applicant who is younger than 17 years of age, and who does not meet the conditions for an exception to the minimum age requirement, may be offered a place in the program of study commencing in the [Semester](#) in which the minimum age requirement will be satisfied.

#### **4.3. International Student Admission**

International students on a student visa are not eligible for admission into a program:

- that is delivered exclusively by online or distance learning;
- where more than one third of the subjects in the program are required to be undertaken via online or distance learning.

#### **4.4. Quotas**

A limit may be placed upon the number of applicants who may be admitted to a program of study or subject in any semester at the discretion of the relevant Executive Dean or Head of UAU.

#### **4.5. Application for Admission**

All eligible Medical Program applicants must apply through the Queensland Tertiary Admissions Centre (QTAC).

All other applicants must apply directly to Bond University via the Online Application form, completing all relevant details including the declaration, and supplying all required documentation.

Subject to other applicable policies and procedures, late applications will be processed only on the authority of the relevant [Faculty](#) or UAU.

#### **4.6. Offers**

##### **4.6.1. Unconditional Offers**

Applicants who successfully meet admission criteria will be offered a place in their preferred program at Bond University, subject to any quotas.

##### **4.6.2. Conditional Offers**

Applicants may be made a conditional offer of a place if they:

- have not yet completed a program required for academic entry;
- meet academic entry requirements but have not yet met English language entry requirements; and/or
- have met the stated entry requirements but supporting documentation has yet to be approved by the University.

##### **4.6.3. Deferrals**

Applicants who are offered a place, and who wish to defer their enrolment until a subsequent semester, must apply in writing for consideration by the Admissions Office. The standard maximum deferral period is three semesters.

Depending on the program being undertaken and the length of time requested, permission to defer may or may not be granted on the authority of the Admissions Office.

Applications for deferral of enrolment in programs subject to a quota may be granted at the discretion of the Faculty of enrolment. Applications will be assessed under the special circumstances criteria and guidelines as set by the *Higher Education Support Act*.

#### **4.6.4. Acceptance of an Offer**

An applicant must accept the offer, meet all stipulated conditions including the submission of any documentation, and pay the required fees by the due date. Failure to accept an offer, pay the required fees, or enrol within the prescribed timeframe will result in that offer lapsing.

#### **4.7. Recognition of Prior Learning**

[Credit](#) may be granted in accordance with the Credit Policy and Credit Procedure.

#### **4.8. Refusal of Admission**

When incomplete, inaccurate, or fraudulent information has been provided by an applicant or by a certifying authority and that applicant is subsequently offered a place, the Admissions Office may direct the offer be cancelled whether or not it has been accepted by the applicant. Fees paid may be forfeited.

The University may withdraw an offer of admission, refuse admission, and/or cancel the enrolment of a student where such offer/admission/enrolment:

- was made on the basis of incomplete, inaccurate, or fraudulent information provided by the applicant or a certifying authority;
- would be contrary to Australian law or, if relevant, the law of another country in which the program is delivered; or
- would be contrary to the University's contractual obligations including those with partner institutions.

The University may refuse any future applications for admission where an application or an offer has been cancelled or withdrawn due to the provision of fraudulent documentation.

For applicants intending to obtain an Australian student visa, if Bond University is not satisfied the applicant is a Genuine Student and/or does not have the capacity to study and live in Australia for the duration of the program, the Admissions Office may direct the offer be cancelled, whether or not it has been accepted by the applicant. The University may impose additional requirements on applicants who will require Australian student visas to commence study. Applicants who do not meet these requirements at the time of application or acceptance will be refused admission.

The University may refuse admission to applicants who would otherwise be eligible if:

- the applicant has outstanding fees owing to the University (the applicant may still be offered a place but will not be permitted to enrol until the debt is cleared);
- the applicant has been excluded from the same program for unsatisfactory academic progress;
- the applicant has been expelled or suspended from Bond University due to misconduct, or is subject to an executive suspension order;
- the applicant has been excluded or expelled from another tertiary education institution for unsatisfactory academic progress or for misconduct; or
- in the opinion of the University Registrar or delegate:
  - the applicant's conduct during the application process would provide reasonable grounds to exclude the person from study for misconduct had the applicant been a student of the University;
  - the applicant or the presence of the applicant poses a risk to the students and/or staff of the University or the wider University community; and/or
  - the admission of the applicant may prejudice the reputation, management, good governance, or discipline of the University.

The University may withdraw an offer of admission where it has been made through administrative error and the applicant does not meet the program entry requirements. If the offer was made to an international applicant and the applicant has accepted the offer, alternatives that do not involve greater cost to the applicant will be considered.

The University, in accordance with the general law, may refuse admission to any program.

#### **4.9. Refusal of Admission following Refusal of further Enrolment**

The University reserves the right to refuse entry to any applicant who has been refused further enrolment in any program within a recognised tertiary institution or who becomes liable for such refusal while the application is being considered.

#### 4.10. Program Change or Re-entry

Applicants who have received an offer and who have not yet commenced study in the program to which they have been admitted, and who wish to change to another program, may make an application to the Admissions Office. If the applicant meets all the requirements for admission to the new program, and if there are still places available in the new program, the application may be approved.

A student who is enrolled in an undergraduate program at the University, yet not met the entry requirements for that program, may be eligible to change to another undergraduate program.

A student who has not completed their current program at the University may apply to change to another program.

To be able to change program, a student must fulfil all requirements for admission to the new program, including admission prerequisites.

A student who has been excluded from a program of study at the University for unsatisfactory academic progress must seek approval from the relevant Faculty or UAU to re-enter the program.

### 5. DEFINITIONS, TERMS, ACRONYMS

<b>Admissions Office</b>	Part of the Office of Future Students responsible for student admissions.
<b>Applicant</b>	A person who has submitted an application for admission to the University.
<b>Credit</b>	The value assigned for the recognition of equivalence in content and learning outcomes between different types of learning and/or qualifications. Credit reduces the amount of learning required to achieve a qualification.
<b>Enrolment</b>	The process whereby a student is formally registered in one or more subjects each semester.
<b>Exchange</b>	The process of attending another institution under formalised exchange agreements between that institution and Bond University. An outgoing exchange student pays all tuition fees to Bond University.
<b>Faculty</b>	Bond Business School, Faculty of Health Sciences & Medicine, Faculty of Law, and Faculty of Society & Design (each of which is headed by an Executive Dean).
<b>HDR</b>	Higher Degree by Research.
<b>Honours</b>	Some Bachelor Degrees may be completed 'with Honours'. This may involve either the completion of a separate Honours Year or additional work in the later years of the program, or meritorious achievement across all years of the program. Honours are awarded by Class (e.g. First Class, Second Class).
<b>Major</b>	A 'major' sequence typically comprises at least six defined subjects within one discipline area; 'double major' means an augmented sequence comprising at least 12 semester subjects within one area of study.
<b>Pathway program</b>	English Program, Foundation Program, or Diploma Preparation Program.
<b>Postgraduate</b>	Graduate Certificate, Graduate Diploma, Masters Degree, or Doctorate.
<b>Semester</b>	A designated academic period, normally of 14 weeks duration including any relevant examination period. Standard semesters in the academic year commence in January, May, and September.
<b>Student</b>	A person who is enrolled in one or more subjects or a research program offered by the University.
<b>Study abroad</b>	The process of attending an approved institution overseas. An outgoing study abroad student pays all tuition fees directly to the other institution.

<b>Subject</b>	A segment of instruction approved by a Faculty or UAU as being a discrete part of the requirements for a program offered by the University and identified by a unique subject code.
<b>Undergraduate</b>	Diploma, Associate Degree, or Bachelor Degree.
<b>University Academic Unit (UAU)</b>	Bond University College (headed by the Director) and Transformation CoLab (headed by the Deputy Provost Education).

## SCHEDULE A

### UNDERGRADUATE ADMISSION REQUIREMENTS

Subject to the limitations imposed by program quotas, the University may admit to an undergraduate program any applicant it believes can undertake the program with a reasonable prospect of success. In determining whether an applicant has a reasonable prospect of success, the University will consider the applicant's previous studies and/or other attainments and experience.

Qualifications deemed eligible for the purpose of assessing admission are as follows:

- Completion of an Australian Senior Secondary Certificate of Education or equivalent qualification
- Previous tertiary studies from an approved provider
- Vocational Education and Training (VET) qualifications including Certificate III, Certificate IV, Diploma and Advanced Diploma recognised under the Australian Qualifications Framework (AQF), subject to the requirements of Schedule C

Other factors taken into account to fully assess the ability of the applicant to successfully complete the requirements of the undergraduate program include:

- a Special Tertiary Admissions Test (STAT)
- relevant working history or experience
- any special or extenuating circumstances
- a portfolio or interview, and/or
- any specific requirements of individual programs

Where a specific qualification is required as the basis of admission, that qualification must be used as the basis of admission. If no specific qualification is required and the applicant has multiple qualifications, the most recent qualification will be used as the qualification for selection and the basis of admission.

Secondary school applicants who completed their study in Australia will be considered for admission into Bachelor Degree programs if they meet the minimum Australian Tertiary Admissions Rank (ATAR) or equivalent for the program.

Individual programs may have specific prerequisites and/or selection requirements. Refer to Schedule D (Medical Program).

Adjustment factors may be applied by the University to elevate a prospective student's overall selection rank, which may assist in meeting eligibility requirements for a specific program.

Applicants who do not meet the minimum entry requirements will be offered a route to their chosen degree via a Bond University College pathway program or a place in an alternative degree program.

In addition to academic entry requirements, applicants will be required to satisfy English language proficiency requirements as specified in Schedule E.

## SCHEDULE B

### POSTGRADUATE ADMISSION REQUIREMENTS

To qualify for entry to a postgraduate degree, diploma or certificate program, an applicant must satisfy the admission requirements outlined in the Academic Programs Policy for the relevant program.

Admission to a postgraduate degree program may be based upon any or all of the following:

- Successful completion of a recognised Bachelor Degree or qualification equivalent to AQF Level 7.
- Other requirements as stipulated by the Faculty or UAU of enrolment.
- Other factors taken into account to fully assess the ability of the applicant to successfully complete the requirements of the postgraduate program include:
  - relevant working history or experience (supported by a curriculum vitae and employment experience verified by a statement of service from the employer on letterhead or via email stating the position title and length of service and a very brief statement on the tasks undertaken)
  - any special or extenuating circumstances
  - a portfolio or interview, and/or
  - any specific requirements of individual programs.

In addition to academic entry requirements, applicants will be required to satisfy English language proficiency requirements as specified in Schedule E.

## SCHEDULE C

### MINIMUM AGE REQUIREMENTS

To meet the age requirement for admission into a program, an applicant must normally be 17 years of age by program commencement date.

If the applicant is under 17 years of age by the first date of enrolment, admission may be approved by the University Registrar if the applicant:

- has the recommendation of the Executive Dean or Head of UAU, or delegate, responsible for the program to which admission is sought (this recommendation may be given subject to conditions);
- complies with any age restrictions imposed by a third party associated with any compulsory program components of practicum or industry experience; and
- lives in Australia with a parent or guardian (including Homestay) as approved by the Australian immigration authority, if they are an international student.

For the English Program, applicants should normally be a minimum of 17 years of age but must be at least 16 years and 8 months of age, by the program commencement date.

For the Foundation and Diploma Preparation Programs, applicants should normally be a minimum of 17 years of age, but must be at least 16 years and 4 months of age, by the program commencement date. The total number of students less than 17 years of age in the Foundation and Diploma Preparation Programs must not exceed 50 percent of the total intake each year.

Applicants using VET qualifications for entry must be at least 18 years of age by the program commencement date unless:

- they have completed the Australian Senior Secondary Certificate of Education or equivalent;
- the admission is more than two years from the completion of an Australian Year 10 or equivalent; or
- the admission is more than one year from the completion of an Australian Year 11 or equivalent.

## SCHEDULE D

### MEDICAL PROGRAM

For the Medical Program, satisfactory completion of Units 3 and 4 in Queensland Senior English or equivalent is required.

For undergraduate applicants, selection is based on:

- overall secondary and/or incomplete tertiary academic results completed within the last nine years;
- psychometric test; and
- structured interview ranking.

Undergraduate applicants must apply through QTAC and meet all published application deadlines, prerequisites and eligibility requirements set by QTAC and the University.

For graduate applicants, selection is based on:

- Grade Point Average (GPA) from the most recently completed eligible tertiary qualification and any further or higher incomplete eligible tertiary studies undertaken within the last nine years;
- psychometric test; and
- structured interview ranking.

Graduate applicants must apply through QTAC and meet all published application deadlines, prerequisites and eligibility requirements set by QTAC and the University.

A limited number of places into Year 2 of the Medical Program are available based upon:

- a minimum cumulative GPA that is the equivalent of a Distinction average across one of the following Bond University programs:
  - Bachelor of Biomedical Science (Health Professional major);
  - Master of Nutrition and Dietetic Practice;
  - Master of Occupational Therapy;
  - Doctor of Physiotherapy; or
  - Master of Healthcare Innovations provided equivalency is established between the applicant's undergraduate Biomedical Science degree and the Bachelor of Biomedical Science at Bond University;
- psychometric test; and
- structured interview ranking.

Year 2 entry applicants must apply directly to the University and meet all application deadlines, prerequisites and eligibility requirements set by the University. This is the only entry pathway to the Medical Program for international applicants.

## SCHEDULE E

### ENGLISH LANGUAGE REQUIREMENTS

1. Students will be admitted on the basis of satisfying criteria for English language proficiency as determined from time to time by Academic Senate and published as entry requirements on the Bond University website, including:
  - a) Achievement of minimum scores on an approved English Language proficiency test taken not more than 24 months before the applicant commences their degree.
    - (i) Unless otherwise approved, the minimum required scores for admission to Bond University programs are:
      - IELTS Academic overall 5.5 (no band below 5.0), or equivalent for Foundation Program entry;
      - IELTS Academic overall 6.0 (no band below 5.5), or equivalent for Diploma Preparation Program and Diploma program entry; and
      - IELTS Academic overall 6.5 (no band below 6.0), or equivalent for undergraduate Bachelor and postgraduate coursework program entry.
    - (ii) The English language proficiency requirements for entry to HDR programs are specified in the Higher Degree by Research Programs Policy.
    - (iii) Clause 2 of this Schedule sets out the approved English language proficiency tests, test concordance, and the programs with minimum required scores higher than that specified in clause 1(a)(i).
  - b) Successful completion of secondary education (equivalent to the Australian Senior Secondary Certificate of Education) that was taught and assessed in English in an approved country (refer clause 3) or International Secondary Schools.
  - c) For specified program levels, successful completion of an approved senior secondary English subject (or equivalent) to a stated achievement level (refer clause 4).
  - d) Successful completion of at least one-year full-time equivalent at a post-secondary level (equivalent to an AQF Certificate IV or above) that is taught and assessed in English in an approved country (refer clause 3). Incomplete qualifications are only valid for 24 months and other validity periods may apply.
  - e) Successful completion of at least one semester full-time equivalent in an AQF Bachelor level or above at an accredited Australian university onshore. Incomplete qualifications are only valid for 24 months.
  - f) Successful completion of the Bond University College English program or equivalent to a stated achievement level (refer clause 5).
  - g) The University may, from time to time, approve alternate English language proficiency requirements for admission to its programs. Approved alternates to the current English proficiency standards are set out in clause 6.

Articulation and partner agreements may result in exemptions to the listed English Language Requirements and details of such exemptions will form part of signed Bond University partner agreements.

Students who experience English language difficulties once enrolled will be referred for academic student support.
