


# Interdisciplinary Colloquium on Sport

Now in its 16th year, we are delighted to announce the 2026 Interdisciplinary Colloquium on Sport examining the dimensions and dynamics of state and non-state actors engaged in sport governance and regulation and the power of sport diplomacy.

The Australian Government's 2023 Statements of Expectations for key agencies highlight a shared commitment to safe, fair, and inclusive sport. Key priorities include strengthening protections against abuse, discrimination, doping, and competition manipulation; promoting gender equity; and enhancing dispute resolution mechanisms. Government agencies are encouraged to collaborate across sectors, contribute to international integrity efforts, and provide strategic advice to government. Submissions are invited that critically engage with these priorities, explore policy and legal implications, and propose innovative approaches to integrity, governance, and athlete welfare in Australian sport.

As with all previous colloquia, our aim is to examine this topic from a multitude of perspectives, bringing together academic, industry and stakeholder perspective. Our goal is to understand and develop insights that transcend disciplinary boundaries and translate into effective and improved outcomes for sport and civic society.

Dr Stuart Murray is Associate Professor of International Relations and Diplomacy at Bond University, Australia. A globally respected scholar and speaker, he specialises in sports diplomacy, traditional and emerging forms of diplomacy, and international relations.
