1. Occupational Therapy Programs – Structure, Enrolment and Assessment

- 1.1 The duration of the [Master of Occupational Therapy](#) (MOT) Program is two years full time and consists of 6 semesters (240 credit points). It is classified as a Level 9 Masters Degree (Extended) within the Australian Qualifications Framework (AQF). The Master of Occupational Therapy includes subjects which are nested in related qualifications including:
- Graduate Certificate in Occupation and Health (AQF Level 8; 40 credit points);
 - Graduate Diploma in Occupation and Health (AQF Level 8; 80 credit points)
 - Professional Doctorate of Occupational Therapy (AQF Level 10; 120 credit points + time-based research and 14- week internship).
- 1.2 The [Graduate Certificate in Occupation and Health](#) is an exit qualification, consisting of four subjects that can be awarded after completion of the first semester of the Master of Occupational Therapy program (May or September intake). **Note:** This program does not lead to professional registration as an Occupational Therapist.
- 1.3 The [Graduate Diploma of Occupation and Health](#) is an entry and exit qualification, consisting of eight subjects that can be awarded after completion of the first two semesters of the Master of Occupational Therapy program. **Note:** This program does not lead to professional registration as an Occupational Therapist.
- 1.4 The [Professional Doctorate of Occupational Therapy \(OTD\)](#) is a nested Higher Degree by Research (HDR) qualification with the Master of Occupational Therapy. Eligible students can apply to convert from the MOT to the Professional Doctorate of Occupational Therapy after completion of all coursework and placement hours as part of the Clinical Research Pathway of the 6-semester MOT. Information about application and eligibility can be found on the program’s website. Detailed information regarding policies and procedures for Higher Degree by Research students, including Professional Doctorate of Occupational Therapy, can be accessed in the [HDR Handbook](#).
- 1.4.1 Professional Doctorate of Occupational Therapy students must complete 24 weeks of Level II fieldwork/practice education as well as an individual 14-week doctoral capstone internship experience following the completion of the required coursework components of the program. The doctoral capstone internship experience must be started after completion of all coursework and Level II fieldwork as well as completion of preparatory activities defined in [2023 ACOTE OTD Standard D.1.3](#). Students must complete all Level II Fieldwork and the Doctoral Capstone experience within 72 months (6 years) following completion of the Occupational Therapy coursework components of the program.
- 1.5 Master of Occupational Therapy students must be enrolled full time within each semester of each year, except for students re-enrolling in subjects which they failed previously or those on an approved modified study pathway. Domestic students may apply to complete the first year of study of the program on a part-time basis with approval from the Head of Program.
- 1.5.1 Master of Occupational Therapy students must successfully complete 24 weeks of Level II Practice Education/Fieldwork within 24 months following completion of the coursework components portion of the program in accordance with [2023 ACOTE OTM Standard A.3.3](#).
- 1.6 Students returning to the Master of Occupational Therapy Program from a leave of absence (LOA) or required leave (Fitness to Study Procedure / Fitness to Practice Policy or exclusion for unsatisfactory academic progress) may have conditions placed on their enrolment. This may include, but is not limited to, being required to complete assessment/s to demonstrate recency of clinical skills/knowledge and ensure they are safe to practice prior to enrolment in a subject

which includes a practice education/fieldwork experience. Conditions may also include being required to pass all subjects in the enrolment period immediately following leave. Such conditions will be advised to the student in writing prior to enrolment as well as the consequences of failing to meet such conditions which may include further conditions being imposed or exclusion from the program.

- 1.6.1 Students joining a different cohort for any reason (e.g., approved LOA, repeat subject or alternative requirement subject) will do so on the understanding that the assessment criteria and standards of the cohort they join will be applied.
- 1.7 In accordance with the requirements of the Occupational Therapy Council (OTC), the Accreditation Council for Occupational Therapy Education (ACOTE), and the World Federation of Occupational Therapists (WFOT), the program includes over 1000 hours of practice education/fieldwork to exceed minimum requirements and to provide students with opportunities to translate theory into practice and consolidate their clinical skills. The practice education/fieldwork experiences are embedded within the program and are classified as 'Level I' and 'Level II' fieldwork. Level I fieldwork is embedded in foundational coursework subjects, as noted in section 1.9 and includes work integrated learning, simulations, case studies, and community-engaged learning experiences. Level II fieldwork consists of one project-focused placement which is linked to the Clinical Research or Business Research streams of the program and two, long-block placements scheduled in the 2nd year of the MOT program (400 hours each, scheduled across 10-12 weeks). The Level II fieldwork placements are assessed using the Student Practice Evaluation Form – Revised Second Edition (SPEF-R2). Successful completion of all practice education/fieldwork experiences outlined below in section 1.9 are required to complete the degree program.
- 1.8 Students must be capable of adhering to the University Fitness to Study Procedure and the Fitness to Practice Policy (herein referred to as 'Fitness Requirements'), including meeting the inherent requirements and expected standards of conduct, compliance, performance and capacity for safe practice. At times there may be instances when aspects of a student's health, wellbeing and/or behaviours raise Fitness to Study and/or Fitness to Practice concerns. These concerns are managed in accordance with the University's [Fitness to Study Procedure](#) and [Fitness to Practice Policy](#).

Coursework subjects are designed to provide students with the necessary theoretical knowledge, practical skill, and clinical reasoning ability to be successful in the clinical practice environment.

Coursework subjects are conducted on campus (except for some Level I fieldwork experiences or excursions) and learning activities are based around forums, seminars, tutorials, simulation experiences, case-based learning, reflection activities, and workshops. The assessment schedule reflects this learning.

The assessment process for Coursework Subjects involves a variety of components including but not limited to:

Scored Summative Assessments

- Written tests / examinations
- Practical skills tests
- Objective Structured Clinical Examinations (OSCE)
- Oral presentations
- Essay/written assignments
- Journal/reflections
- Supervisor/ Clinical Educator evaluations
- Research outcome / thesis (research subject only)

2.1 Overview of the Rules of Progression

2.1.1 There are several assessment items for each coursework subject. The Subject Outline (and associated iLearn site) for each subject state the Assessment Schedule and the weighting of each assessment item. **All assessment tasks must be submitted by the due date unless an extension or deferral has been approved in accordance with the Subject Outline and Bond University's Assessment Procedure.**

- 2.1.2 Students must achieve a passing standard for the subject overall. If a student Fails a mandatory assessment item of a subject (also referred to as a 'hurdle' assessment), they will fail the subject overall. Additional pass requirements may exist for individual subjects, and these are stipulated on the subject outline (and associated iLearn site).
- 2.1.3 If a student does not demonstrate they have achieved the required level to pass the subject, a resit assessment may be available where specified in the subject outline (ref: [Assessment Procedure – Resit Assessment Procedure Schedule E5](#)). A fail in the resit assessment item will result in a grade of RF (resit fail) for the subject overall.
- 2.1.4 If a student has failed any **TWO** coursework subjects in the program, and they fail a **THIRD** coursework subject, the student may be excluded from the program.
- 2.1.5 Where a student fails a coursework subject that is a prerequisite for subsequent subjects, the student will be unable to progress into the next subject (whether that be a subsequent coursework or practice education/fieldwork placement subject). The student will be required to retake and successfully complete the failed subject before progressing.

Should a student fail a coursework subject, subject to other rules of progression, they will be given the opportunity to repeat the coursework subject when it is next offered up to a maximum of **TWO** repeats

2.2 Deferred, Supplementary and Resit Coursework Assessment

Deferred, supplementary and resit procedures in relation to coursework assessment are managed in accordance with the [Assessment Procedure](#) – Schedules E3, E4 & E5.

2.2.1 Deferred Assessments

A student who experiences exceptional circumstances and is unable to sit **in-semester assessments** including written, practical skills assessment, or objective structured clinical examination (OSCE) may be eligible to apply for a deferred assessment using the [HSM Application for Extension/Deferral for Assessment](#) with supporting evidence.

Applications for deferring Mid-Semester Examination (Timed) scheduled in Week 6 – 8, or Final or End-of-Semester Examination (Timed) scheduled in Week 13 – 14, must be lodged by completing the [Deferred Assessment Application](#) within two (2) working days following the day of the scheduled assessment ([Assessment Procedure](#) – Schedule E3 and Schedule F).

Students who are unable to sit the approved deferred Mid- or End-of-Semester examination due to exceptional circumstances may be eligible to apply for withdrawal without penalty. Application will be assessed by Student Assist in accordance with the Withdrawal Without Penalty Procedure.

2.2.2 Resit Assessment

The resit assessment is a pass/fail assessment that may be granted to a MOT student who Fails a compulsory assessment item within a subject. For resit assessments, students may be eligible to resit the compulsory assessment component of the subject that caused them to fail in accordance with the [Assessment Procedure](#) - Resit Assessment Procedure - Schedule E5. Resit opportunities are outlined in each subject outline. In this instance, the student will be allocated a non-finalised grade of Remediation Granted (RM) and will be offered a process of remediation prior to their resit assessment.

If a student undertakes a resit assessment and passes, they will be awarded a finalised grade of Resit Pass (RP).

If a student undertakes a resit assessment and fails, they will be awarded a finalised grade of Resit Fail (RF) and issued an Academic Warning. The student will also be placed on the Faculty Academic Monitoring Register. Students who receive a final grade of Resit Fail (RF) may be eligible to apply to repeat the failed subject when it is next offered.

If a student is invited to undertake a resit assessment and is unable to do so, then their original result will stand. In this instance, the student will be awarded a Fail grade for the assessment item and overall subject and be required to repeat the coursework subject when it is next offered.

2.2.3 **Determining the passing score for the Resit / Deferred Assessment**

The calculation of a passing score for the resit will be Ungraded Pass (UGP) / Ungraded Fail (UGF), and the student will be required to demonstrate the knowledge, skills, and competency to progress to the next subject. For a student completing a deferred assessment, the full scale of grades will be applicable. Please refer to the [Assessment Procedure – Award of Grade Procedure Schedule B](#) for the grading systems relevant to the MOT Program and [Assessment Policy TL 3.5.1](#).

2.2.4 **Supplementary Assessment**

Students should refer to Schedule E5 in the [Assessment Procedure](#) for information on eligibility and the process of applying for a supplementary assessment.

2.3 **Process for repeating coursework subjects**

2.3.1 A student who has failed a coursework subject with an Academic Warning will meet with the Head of Discipline and Student Affairs and Service Quality (SASQ) staff (ref: [Academic Progress Policy SS 5.4.5](#)). The student will be formally informed that they are at risk of failing the program with referrals to relevant academic and pastoral support services.

The student will be placed on the Faculty's Academic Monitoring Register within the program.

2.3.2 The student will be required to meet with the Academic Coordinator of Clinical Education to develop a plan for their remediation and progression into practice education/fieldwork placement once the coursework subject has been successfully passed.

3. **Overview of MOT Professional Practice Education / Fieldwork Experiences**

Practice education includes both Level I and Level II supervised and assessed experiential learning activities conducted on-campus, virtually or in external clinical and community settings (fieldwork). Supervision is provided by AHPRA registered occupational therapists and/or other qualified professionals. Successful completion of all practice education/fieldwork experiences outlined below are required to complete the degree program.

The assessment process for professional practice education/ fieldwork experience involves a variety of components which are outlined in relevant subject outline and iLearn sites including but not limited to:

- **SPEF-R2** (for Level II placement) or **Bond Supervisor Evaluation of Student Performance** (for Level I placement) are graded as pass/fail. This is completed by the assigned clinical educator(s)/supervisor(s).
- Fieldwork reflection and professional portfolio
- Learning agreement
- Practice Education Log of Hours

Note 1: The **SPEF-R2** and **Bond Supervisor Evaluation of Student Performance** assesses performance across a range of domains including:

1. Professional Behaviours
2. Self-Management Skills
3. Co-worker Communication
4. Communication Skills
5. Documentation
6. Information Gathering
7. Service Provision
8. Service Evaluation
9. Project and consultative performance

Note 2: **All assessment tasks and required practice education documentation must be submitted by the due date unless approved extension has been granted. Failure to submit all required documentation on time may result in a Fail grade for the subject.**

3.1 Overview of the Rules of Progression for Professional Practice Education/Fieldwork Experiences

- 3.1.1 All required compliance for practice education/fieldwork experiences must be completed and submitted by published due dates in accordance with the [Health Sciences & Medicine Compliance requirements](#) and [Occupational Therapy Program Student Charter](#). Any student who fails to meet compliance requirements will not be allocated to a practice education placement and will be referred to the Head of Program. Ongoing non-compliance by students will be referred directly to the Associate Dean of Student Affairs and Service Quality (AD SASQ). This is likely to impact progression in the program.
- 3.1.2 Whilst on placement, there will be regular supervision with the supervisor/clinical educator. For level II long block placements (Innovation Projects in OCT71-402, OCTY71-404, OCTY73-700 Professional Practice in Occupational Therapy I and OCTY73-701 Professional Practice in Occupational Therapy II), the clinical educator will be using the SPEF-R2 to assess the student's performance.
- 3.1.3 The student is expected to engage in regular supervision and formative evaluation throughout the placement, including self-evaluation and reflection. There will be a formal formative assessment at the halfway point and a final summative assessment using the SPEF-R2 for Innovation Projects, OCTY73-700 and OCTY73-701 practice education placements.
- 3.1.4 The **Bond Supervisor Evaluation of Student Performance** and/or specific marking criteria and rubrics will be used to assess level I practice education experiences, which are embedded in specified coursework subjects.

- 3.1.5 Students must address the identified criteria to obtain a **pass** in a practice education/fieldwork experience. The student must be assessed as competent on all domains of the SPEF-R2 (Level II fieldwork) or the **Bond Supervisor Evaluation of Student Performance** (Level I fieldwork). The overall grade for Level II Fieldwork subjects OCTY73-700 Professional Practice in Occupational Therapy I and OCTY71-701 Professional Practice in Occupational Therapy II will be either Ungraded Pass (UGP) or Ungraded Fail (UGF).
- 3.1.6 During Level II Fieldwork placement (Innovation Projects, OCTY73-700 and OCTY73-701), should concerns regarding the student's performance in relation to the SPEF-R2 domains be raised by the Practice Education supervisor, the student will be expected to develop and implement a remediation plan in collaboration with the Academic Coordinator of Clinical Education and Practice Educators. The student will be placed on the Faculty Academic Monitoring Register as per [Support for Students' Policy SS 5.8.2](#). If there is insufficient evidence of remediation in response to areas of concern and feedback on the SPEFR-2 assessment and significant safety concerns remain after a period of remediation, the placement may be terminated early, and the student will receive a Fail grade for the subject which may impact on their academic progression and successful completion of the program.
- 3.1.7 Resit grades are not available for Level II practice education placement subjects (OCTY73-700 and OCTY73-701) as the assessment process is continuous and there are embedded formative assessments throughout the placement. In the event of placement failure, the student will be offered an opportunity to repeat the entire placement subject, and all placement hours.
- 3.1.8 If a student is unable to undertake the placement for the remediation and the remediation cannot occur, the student will fail the placement. The student will be required to repeat the full placement when it is next able to be offered for successful progression in the program.

In the case of a failed placement, the student will be supported to a reasonable degree (as per Clause 4.1 of the Support for Students Policy SS 5.8.2) by assigned staff and resources put in place to develop a specific and individualised learning plan and goals to address areas of concern, as documented in the SPEF-R2.

A remediation plan will be developed in consultation with the Academic Coordinator of Clinical Education and recommendations will be made for the student to engage in self-directed learning and remediation activities to develop competency, safety, and readiness for placement at the level expected of a student at the point in the degree in which the failed placement occurred.

3.2 Process for Repeat or Modification of Level II Professional Practice Education Subjects (OCTY73-700 and OCTY73-701)

- 3.2.1 A student who Fails a Level II professional practice education subject will meet with the Head of Discipline and the Academic Coordinator of Clinical Education (or delegate). The student will be officially informed that they are at risk of not progressing in the program based on professional and clinical performance. The student will be placed on the Faculty Academic Monitoring Register as per [Support for Students' Policy SS 5.8.2](#) to ensure they are able to access the available support to assist them with their progression in the program. A revised study plan approved by the Head of Discipline will be provided by SASQ to the student.

- 3.2.2 Resit opportunities are not available for Level II practice education subjects (OCTY73-700 and OCTY73-701) as the assessment process is continuous and there are embedded formative assessments throughout the course. In the event of placement failure, the student will be offered an opportunity to repeat the entire placement subject, and all placement hours.
- 3.2.3 A student is only able to repeat a Level II Practice Education/Fieldwork placement (Innovation Projects, OCTY73-700 or OCTY73-701) **ONCE**. A second fail of a Level II Practice Education/Fieldwork placement (Innovation Projects, OCTY73-700 or OCTY73-701) will result in the student being excluded from the program
- 3.2.4 A student who experiences exceptional circumstances and is unable to undertake a practice education/fieldwork subject in the designated period should, in the first instance, meet with the Head of the Discipline (or designated delegate – such as the Academic Coordinator of Clinical Education) to discuss options for a revised study plan. Students should note that a revised study plan in the program is likely to impact the students' program scheduled completion.
- 3.2.5 Withdrawal from a practice education/fieldwork placement is likely to result in delayed course progression and program completion time and graduation.

4. Attendance Requirements

Overview

Occupational Therapy programs are by nature, intensive and include forums, seminars, workshops, tutorials, laboratory and resource/practical sessions, clinical skills sessions, and practice education/fieldwork placements. This combination of learning opportunities is carefully designed and scheduled to guide students towards meeting intended program learning outcomes. Students are required to attend ALL scheduled sessions (ref: [Assessment Procedure](#) – Class Attendance and Participation Procedure Schedule C).

Please see the [Occupational Therapy Program Charter](#) for more details. The only exception will be for suitable professional activities that are aligned with the program goals and outcomes and where prior approval for absence has been granted by the Head of Program.

- 4.1 It is the student's responsibility to ensure that they adhere to the Attendance requirements and be aware of their attendance status (ref: [Assessment Procedure](#) – *Class Attendance and Participation Procedure Schedule C*).
- 4.2 Students are expected to complete the "Request for an Approved Absence Form" for any intended or unintended absence. This form is located on the OT Community iLearn site.
- 4.3 Absence from one (1) or more scheduled learning sessions on a specific day will be recorded as one (1) day of absence only.
- 4.4 Students with an absence greater than 10% of scheduled days in a single subject will result in the student being placed on the Faculty Academic Monitoring Register. See section 5 for details.
- 4.5 Students who are absent from a practice education experience or placement for any reasons will be required to make up the practice education hours. Faculty staff will arrange make-up hours. There are no guarantees that the make-up hours will be possible in the placement facility in which the student undertook the original placement. The requirement to undertake make up hours for a professional practice education placement subject may result in a delayed progression through the program.

5. Faculty Academic Monitoring Register

Overview

The Faculty of Health Sciences and Medicine is dedicated to shaping professionals who are distinguished, not just by their scientific clinical skills but by their professionalism, namely their skills in ethics, empathy, communication, and collegiality.

The Faculty aims to ensure that students at risk of not progressing satisfactorily and/or requiring support are identified as soon as possible and that appropriate interventions are implemented and monitored by academic, administrative and support staff ([Support for Students' Policy SS 5.8.2](#)).

- 5.1 Students who are placed on the Faculty's Academic Monitoring Register and require academic or personal support may be identified through unsatisfactory academic performance, poor behavioural and/or professional attributes, including but not limited to the following:

5.1.1 Academic performance

Unsatisfactory academic performance as determined by performance in formal assessments and examinations as ratified by the Board of Examiners (BOE) at the end of each semester. Unsatisfactory academic performance in practice education/fieldwork placements can also be determined by the Clinical Educator in consultation with the Academic Coordinator for Clinical Education and/or Head of Discipline and ratified by the BOE.

5.1.2 Attendance

Unsatisfactory attendance at scheduled learning sessions.

5.1.3 Behaviour

- Behaviour, which is consistently unprofessional, disruptive, volatile, or otherwise not aligned to the [Occupational Therapy Program Charter](#), [Bond University Student Charter](#) and/or [Student Code of Conduct Policy SS 5.2.1](#) and/or the [AHPRA Code of Conduct](#), including health-related matters which are not professionally self-managed.
- Behaviour which is considered in breach of any applicable documents which define or outlines professional behaviour, personal behaviour, fitness to practise, ethical behaviour or conduct established by organisations hosting students on placements.

5.1.4 English Language Proficiency

In accordance with the guidelines of the Australian Health Practitioner Regulatory Agency (AHPRA) and Occupational Therapy Council of Australia, students must demonstrate proficiency in verbal communication in English to a standard that allows fluid, clear, and comprehensible two-way discussions for patient care, tailored to the local English-speaking audiences.

- 5.2 Support for students placed on the Faculty Academic Monitoring Register (ref: [Support for Students' Policy SS 5.8.2](#)).

- 5.2.1 At the end of each semester, the BOE identify students as requiring academic support will be placed on the Faculty's Academic Monitoring Register and are required to participate in remedial and/or support activities. The remedial and/or support activities may include but are not limited to the following:

- Scheduled meetings with Head of Program or delegate
- Scheduled meetings with the Academic Coordinator of Clinical Education

- Scheduled meetings with the University support services including two (2) sessions with the Academic Skills centre.

5.2.2 Students in need of support may also be identified through low academic performance (**where their semesterly GPA is a fail or within one standard deviation**), communication, behaviour and/or professional attributes. Whilst not warranting placement on the Faculty's Academic Monitoring Register such students may be deemed to be of low academic status and may still be identified as appropriate for referral to additional support services as deemed necessary.

6. Management of Student Misconduct

Upon confirmation of enrolment, Bond students are bound by all University policies and procedures including the [Student Code of Conduct Policy SS5.2.1](#), [Faculty protocols and rules](#), and associated program charter and inherent requirements.

Students who fail to adhere to academic and professional standards are dealt with under the [Student Code of Conduct Policy SS5.2.1](#) and the relevant associated procedure ([Student Academic Misconduct Procedure](#) or [Student General Misconduct Procedure](#)).
