The Bachelor of Business/Bachelor of Commerce with an Accounting Major comprises 30 credit points of Core Curriculum Subjects, 130 credit points of Required Subjects, 60 credit points of the Accounting Major, 60 credit points of a Business Major, and 40 credit points of General Electives, totalling 320 credit points over eight semesters. The program combines broad business and commerce foundations with specialised accounting studies. Students develop advanced capabilities in financial accounting, management accounting, taxation, auditing, accounting information systems, financial reporting, business strategy, economics, finance, leadership, and organisational management. Through completion of the Accounting Major, students gain the technical and professional competencies required for careers in accounting, auditing, taxation, financial management, business advisory, and related professional accounting fields, while also developing expertise through their chosen Business Major.			
Assumed Knowledge			
Assumed knowledge is the minimum level of knowledge of a subject area that students are assumed to have acquired through previous study. It is the responsibility of students to ensure they meet the assumed knowledge expectations of a specified subject. Students who do not possess this prior knowledge are strongly recommended against enrolling and do so at their own risk. No concessions will be made for students' lack of prior knowledge.
