The Bachelor of Business/Bachelor of Laws is a combined undergraduate degree comprising 440 credit points completed over 11 semesters (approximately 3 years and 9 months full-time). Students complete 30 credit points of Core Curriculum subjects, 240 credit points of required subjects, a 10 credit point Statistics Option, a 60 credit point Business Major, 70 credit points of Law Electives, and 30 credit points of General Electives. Students may also undertake optional law majors or specialisations. The degree prepares graduates for careers in legal practice, business management, corporate governance, consulting, entrepreneurship, financial services, and commercial advisory roles, combining professional legal qualifications with a strong business education.			
Assumed Knowledge			
Assumed knowledge is the minimum level of knowledge of a subject area that students are assumed to have acquired through previous study. It is the responsibility of students to ensure they meet the assumed knowledge expectations of a specified subject. Students who do not possess this prior knowledge are strongly recommended against enrolling and do so at their own risk. No concessions will be made for students' lack of prior knowledge. Please check for all requirements on your subject outline prior to enrolment.
